

## Disclaimer for Use of Images

### **Whereas**

- A. IGPDecaux S.p.A. ### **By signing this Disclaimer, each signatory**

- 1. Declares, under his/her responsibility, that he/she has already reached the age of 18 years at the present date and therefore has legal capacity;
- 2. Assigns, free of charge, to IGPDecaux the right to use, disseminate, reproduce, publish, disclose to the public - through IGPDecaux institutional website or social media pages, as well as through the social media pages dedicated to the Contest or even through printed publications - and transmit on any type of paper or digital medium, his/her image, as contained in the images created during the Contest, for all the commercial, promotional and advertising purposes related to the Contest and the IGPDecaux brand; assigns IGPDecaux all existing rights of any kind in the Images necessary for the commercial, promotional and advertising exploitation of the Images;
- 3. Expressly declares that he/she is fully satisfied and has nothing to claim from IGPDecaux and its assignees and/or successors in interest, for any reason whatsoever, and that he/she undertakes not to raise any objection, claim or dispute in this respect, including in the future, and, as far as possible, irrevocably waives any right, action or claim in connection with the payment of fees, considerations or indemnities whatsoever in connection with the foregoing;
